Primary action	Review the disclosure, confirm PDF access, enter the code, then select Subscribe .

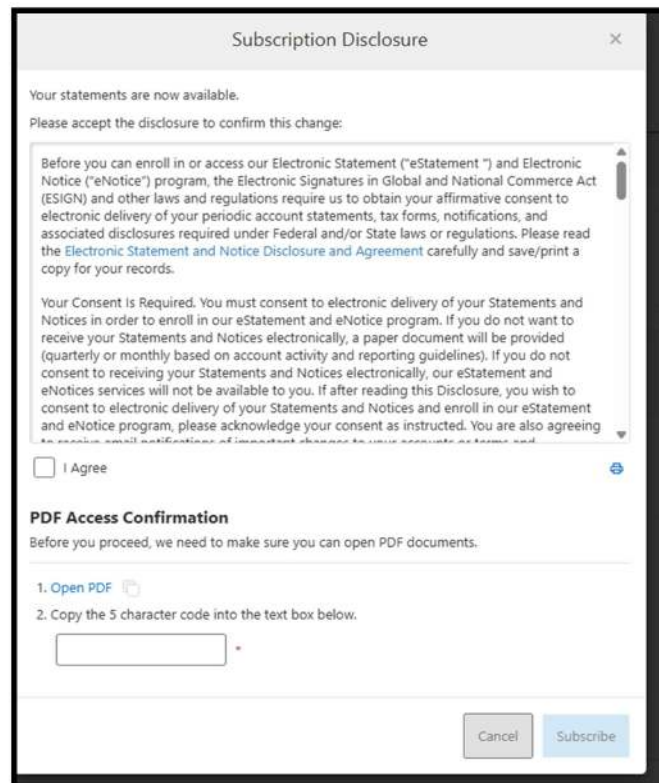
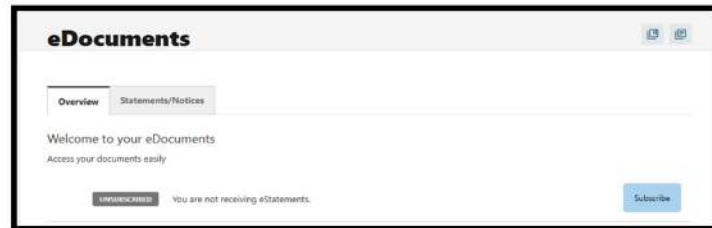
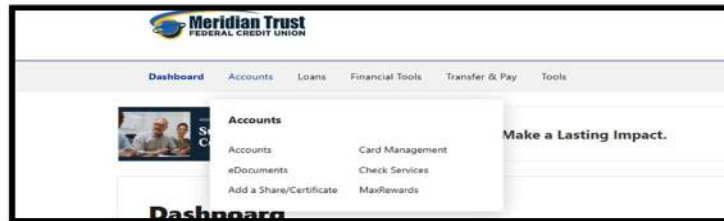
Enrollment at a glance

- 1 Open eDocuments**
 From online banking, go to **Accounts**, then choose **eDocuments**.
- 2 Click Subscribe**
 On the eDocuments overview page, select **Subscribe** to begin enrollment.
- 3 Review disclosure**
 Read the Subscription Disclosure, then check **I Agree** to consent to electronic delivery.
- 4 Confirm PDF access**
 Select **Open PDF**, copy the 5-character code, and paste it into the confirmation field.
- 5 Finish enrollment**
 Click **Subscribe**. The page should show **SUBSCRIBED** and confirm eStatements are active.

Tip: The PDF code is a security check. Members should copy the exact 5-character code shown in the PDF confirmation window before clicking Subscribe.
