1. Sponsor

This Sweepstakes is sponsored by Meridian Trust Federal Credit Union ("Meridian Trust" or "Sponsor"), located in Cheyenne, Wyoming.

2. Promotion Period

The Meridian Trust eStatements Enrollment Sweepstakes ("Sweepstakes") begins at 12:00 a.m. Mountain Time on August 1, 2026, and ends at 11:59 p.m. Mountain Time on August 31, 2026 ("Promotion Period").

3. Eligibility

The Sweepstakes is open to natural persons who meet all eligibility requirements below.

- Are legal residents of the United States;
- Are at least 18 years of age at the time of entry;
- Meet Meridian Trust membership eligibility requirements.

The following individuals are not eligible to participate:

- Meridian Trust employees;
- Members of the Board of Directors;
- Members of the Supervisory Committee;
- Immediate family members living in the same household as any of the foregoing individuals.

Void where prohibited by law.

4. How to Enter

Eligible individuals may enter the Sweepstakes during the Promotion Period by either method below.

Method 1 - eStatements Enrollment: Enroll in Meridian Trust eStatements during the Promotion Period.

Method 2 - Free Alternate Method of Entry (AMOE): Submit a handwritten entry including full name, mailing address, phone number, and email address, if applicable.

5. Entry Limits

- Limit one (1) entry per eligible person.

- Entries become the property of Meridian Trust and will not be returned.

6. Prizes

Five (5) winners will each receive one (1) \$100 gift card. The Approximate Retail Value ("ARV") of each prize is \$100. The total ARV of all prizes is \$500.

Meridian Trust reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable. Prizes are non-transferable and may not be redeemed for cash except where required by law.

7. Winner Selection

On or about September 5, 2026, Meridian Trust will conduct a random drawing from all eligible entries received during the Promotion Period.

The decisions of Meridian Trust regarding the administration of the Sweepstakes, winner selection, and all related matters shall be final and binding.

8. Odds of Winning

Odds of winning depend upon the total number of eligible entries received.

9. Winner Notification

Winners will be notified using the contact information maintained by Meridian Trust or provided with the Sweepstakes entry.

- If a selected winner cannot be contacted;
- Fails to respond within a reasonable period; or
- Is determined to be ineligible, Meridian Trust may select an alternate winner.

10. Taxes

Any federal, state, or local tax obligations associated with acceptance of a prize are the sole responsibility of the winner.

11. Publicity Release

Except where prohibited by law, acceptance of a prize constitutes permission for Meridian Trust to use the winner's name, city of residence, photograph, and likeness for promotional purposes without additional compensation.
